Social Cycling Austin Admins, Moderators, Leaders and Members accused a Ride Bikes Austin Organizer of wasting the city's time by putting in a request to speak and then not being present.

A Bicycle Advisory Council Administrator notified the organizer by email that the chairs would "hopefully" add her request to speak to their next agenda [5/16/23] and that their "agenda and presenters [were] already set up for the meeting on Tuesday [4/18/23].

There was a mixup and the Organizer's name was added to the agenda without her knowing. The miscommunication was cleared up with mutual respect and Nona received an apology from the Bicycle Advisory Council Administrator.





We submitted written request to Jason Abels requesting that he stop harassing us through repeated unwanted contact. Instead, he doubled down on his campaign of hate toward us by continuing to regularly create dogpile posts, engage in concern trolling, and by regularly (publicly) directing others to contact us on his behalf in public social media posts. He escalated his attacks at Critical Mass Austin #11 5/27/22 when he rode into the oncoming lane and hit a woman's rear-view mirror hard enough to break it off. We stopped the ride to denounce the behavior and requested that he leave. Jason refused to leave and responded "Welcome to Critical Mass."







Kim Vozar is not a credible witness regarding whether "threats and harassment" were issued at RBA organizers because she was not present at "Critical Mass Austin #21 - 3/31/23". Kim's statement that there was an "unplanned merging" is false as Corina Oliva-Hansen reported, "I'll take responsibility for bringing the rides together. It was bound to happen at some time. It's a question that gets repeated each month...I feel I gave the people what they wanted." 4/5/23, 3:42 PM

Kim's statement that "Critical Mass was started as an idea years ago to encourage all of Austin's various social cycling groups to come together to ride across the city," is false. Critical Mass was started in San Francisco in 1992 "by cyclists and activists who wanted to increase the visibility of bicyclists and reclaim public space by making social use of the streets on a regular basis."

The individuals mentioned in the document Kim refers to chose to behave in the manner in which they did or they publicly reported their involvement at the "merger." RBA Organizers have no influence over the fact that they were all Social Cycling Austin Admins, Ride Leaders, Members, and Organizers (those are just facts).

Kim's statement that RBA "does not allow SCA members on their rides" is false. There are a handful of SCA Ride Leaders and Moderators that ride with RBA regularly. There are several RBA members and one organizer that regularly attends group rides affiliated with SCA.

The name of the "14-Year Member" and anyone else whose name was redacted from publicly available files are available in the same "unredacted" folder this file is in.

RBA has never made any claims that "SCA [was] consistently engaging in promoting...dangerous activities." However, SCA Admins, Ride Leaders, Members, and Organizers have continued engaging in or condoning acts of harassment aimed at RBA for almost 2 years.

The claim that SCA regularly finds itself at the end of the RBA combative stick is perplexing as RBA organizers do not show up to SCA events, do not make public or private posts about SCA on group or personal pages and voluntarily left SCA in an effort to evade the group altogether as they perceive it to be toxic and disagree with the laissez faire attitude regarding harassment meanwhile perpetuating it by not holding its Organizers, Admins, Ride Leaders or member accountable.

Ironically, Kim, has engaged in adding negative and untrue commentary to dogpile and concern troll posts
